

Notice that Injured Employee has Right to Legal Representation

Injured workers may represent themselves in matters before the Board or may retain an attorney or licensed representative to represent them. If an attorney or licensed representative is retained, his/her fee for legal services will be reviewed by the Board and if approved will be paid by the employer or insurance company out of any compensation benefits due. Injured workers should not directly pay anything to the attorney or licensed representative in a compensation case. An injured worker may access an attorney by contacting the state, county or local bar association. A list of licensed representatives can be obtained by contacting the Board District Office.
