Your NHRLA Legislative Committee and our lobbyist, Curtis Barry, remain active and closely connected to the state legislators and the Governor's office.

In 2023, the NHRLA will be focusing on many bills, including SB26-FN, which would provide asbestos suit defendants with no connection to the plaintiff's claim a way to avoid being sued or having their case dismissed earlier.
