### Legislative Representation

Under the leadership of Jay Mahoney, the Massachusetts Retail Lumber Dealers Association's legislative committee is actively engaged in initiatives crucial to the LBM (Lumber and Building Materials) industry. Given Massachusetts' challenging business climate, which currently ranks second to last in terms of cost, the committee's focus for 2024 is paramount for the industry's vitality.

Of particular concern are issues directly impacting the LBM sector, such as opposition to new taxes, which could burden businesses and hinder growth opportunities. Additionally, the committee is vocal about the transition to all-electric vehicles, recognizing its potential impact on transportation costs and logistics for the industry. Supporting construction and development initiatives is also central to the LBM industry's interests, as these efforts drive demand for lumber and building materials, sustaining the industry's growth and viability.

Nationally, ABMA, powered by NRLA and CSA, continues to advocate for our members on vital issues like the Softwood Lumber Agreement, tax matters (including the bonus depreciation tax credit), and the Employer Directed Skills Act. These priorities have a direct impact on the broader LBM industry, influencing the tax environment, supply chains, and business investments. Your continued engagement is essential as we collectively navigate and shape the future of the Massachusetts LBM industry.
