Legislative

The RLDAM Leaislative Committee, with lobbyist Dan Riley, continue to foster strong ties with state legislators and the Governor's office. In 2024, efforts included successfully blocking a bill to decriminalize retail theft through a Governor's veto. The Governor's official message credited the outpouring of input from retailers like RLDAM members as a key reason for the decision. The committee remains dedicated to supporting the business community by directly shaping impactful legislation.

Nationally, American Building Materials Alliance (ABMA), supported by Northeastern Retail Lumber Association (NRLA) and Construction Suppliers Association (CSA) is focused on federal issues critical to the LBM industry, such as revising new CDL training requirements, promoting a business-friendly tax environment, and engaging with OSHA on proposed rulemaking to address industryspecific concerns.
