### Legislative Representation

Under the leadership of Long Island's Dana Schnipper, NYLILA continues to achieve significant results through NRLA-NY's legislative committee. In 2024, the committee successfully advocated for a legislative package to crack down on retail theft, providing stronger protections for businesses across New York. Additionally, the committee played a pivotal role in securing a veto of the TREES Act, which would have imposed burdensome restrictions on wood products, potentially disrupting supply chains and increasing costs.

Nationally, American Building Materials Alliance (ABMA), supported by Northeastern Retail Lumber Association (NRLA) and Construction Suppliers Association (CSA), actively champions issues critical to the LBM industry, such as updating CDL training requirements, fostering a business-friendly tax environment, and influencing OSHA rulemaking to reflect industry-specific needs.
