## Legislative

The NHRLA Legislative Committee, led by Bob Jackman and supported by lobbyist Curtis Barry, remains highly engaged with state legislators and the Governor's office. In 2024, the committee achieved a major success by defeating a bill that would have required retailers to list the actual dimensions of lumber. This proposal threatened to disrupt industry standards and risk the obsolescence of the iconic 2x4.

Under the leadership of Rod Wiles, Nationally, American Building Materials Alliance (ABMA) has outlined an ambitious 2025 legislative and regulatory agenda to strengthen the LBM industry and tackle key challenges. On the legislative front, ABMA is prioritizing policies that support Main Street businesses, including bonus depreciation, immediate expensing, and estate tax reform. With credit card transaction fees rising, ABMA is pushing for solutions to ease these costs for retailers. Workforce development also remains a central focus, with efforts to expand training programs and address labor shortages.

Regulatory advocacy will target CDL licensing and crane certification, pressing for industry-specific training options that better align with building materials operations. ABMA is also working to ensure that any changes to salaried overtime regulations are practical for the LBM industry.

In addition to these priorities, ABMA is closely monitoring OSHA's proposed Heat Illness and Injury Prevention Standard, the Corporate Transparency Act, and tariff developments that could impact material costs. By maintaining a proactive presence on these issues, ABMA continues to advocate for policies that empower its members and drive growth across the LBM industry.
