Legislative Representation

Under the leadership of Jay Mahoney, the Massachusetts Retail Lumber Dealers Association's legislative committee is actively addressing key issues critical to the LBM industry.

The committee has prioritized policies to promote home building through streamlined building codes, housing bonds, and workforce development initiatives, including career and technical education and multilingual forklift training. A major concern remains the phased transition to all-electric trucks, which began this year. The committee has been vocal in advocating for a delay to address logistical and cost challenges impacting the industry's transportation infrastructure.

Nationally, American Building Materials Alliance (ABMA), supported by Northeastern Retail Lumber Association (NRLA) and Construction Suppliers Association (CSA), is focused on a business-friendly tax package, reducing credit card swipe fees, and supporting workforce development initiatives. On the regulatory side, ABMA has cultivated a strong partnership with the Small Business Administration and secured a seat at the table during OSHA rulemaking processes. This critical engagement allows ABMA to provide industry-specific feedback on proposed rules, ensuring the unique needs of the LBM sector are represented.
