Legislative

Our state advocacy is focused on protecting our independent LBM businesses' bottom line.

State Priorities – Maine (RLDAM)

- Opposing mandatory reporting of gender-based wage gaps that would impose new mandatory administrative burdens on employers.
- Fighting mandatory flexible scheduling requirements that would create mandatory staffing rules and limit an employer's ability to manage their workforce.
- Pushing back on proposals for steep increases in mandatory overtime thresholds, significantly raising payroll costs for small businesses.

At the national level, the American Building Materials Alliance (ABMA) advanced several major wins:

- Securing passage of the Big Beautiful Bill, a major federal tax package that includes LBM-specific benefits such as improvements to the estate tax and small-business expensing
- Rolling out a national housing policy proposal focused on reducing the hidden costs of government red tape, bringing more homes into the price range the average American family can afford

On the regulatory front, ABMA continues to expand its influence. Through a strong partnership with the U.S. Small Business Administration:

- Fixing CDL driver shortages by addressing expensive, one-size-fits-all training requirements.
- Reforming crane certification standards that don't reflect real-world LBM boom-truck operations
- Pushing back on OSHA's proposed heat rule—1,000+ pages of new red tape triggered anytime temperatures exceed 80°F
